

Transport and Fleet Driver Privacy Notice

1. Introduction

Biocair have obligations to meet the contractual requirements of our clients, comply with legal obligations and a duty of care to protect the safety and welfare of our drivers. To support the business we have implemented a software program, Samsara, which provides vehicle tracking technology and forward-facing dashboard cameras (Dashcam). The functionality of Samsara will monitor the temperature of temperature-controlled packages on route for delivery, real-time GPS fleet tracking to monitor the location of packages, monitoring driver hours, vehicle speeds and manoeuvring. In addition, incentive-based driver behaviour points will be collected with the aim of rewarding careful driving, recording road traffic incidents, accidents and driving offences, in the event these occur.

Biocair are registered with the UK Information Commissioner's Office (Z5321583) and are committed to protecting your privacy and complying with the applicable data protection laws.

3. What is the source of this information?

We receive your personal data directly from the Samsara application.

4. How do we use this information and what is the legal basis for this use?

We process your personal data listed in Section 2 for complying with our legal responsibilities, to provide real time delivery information to clients and protect the safety and welfare of our drivers.

5. With whom and where will we share your personal data?

The Transport Dept do not share your data hosted in the Samsara application with any other party and access to the application is restricted to authorised personnel only.

6. How long will you keep my personal data?

Dashcam keeps data for 6 months, GPS Tech kept by Samara indefinitely, Biocair will keep GPS for lifespan of vehicle 5yrs maximum.

7. Data Storage and Transfers

The Samsara application is hosted by Amazon Web Services (AWS) in the USA. In adherence to the general principles for data transfers, we ensure a transfer impact assessment is undertaken and an International Data Transfer Agreement is implemented with Samsara.

8. What are my rights in relation to my personal data?
